I recently contacted Councilman Culbertson regarding any updates regarding the Bluebonnet Extension. I was prompted to do so after hearing rumors that the plans for construction of the roadway were underway. For those of you who are new to the neighborhood and are unfamiliar with the Extension, please refer to our website which has some useful information that can bring you "up to speed" as to what has occurred in the past 24 months. The commitment from DPW is firm – when the time comes, DPW will meet with the committee members from Bluebonnet Highlands and discuss the planning/design of this roadway. Mr. Raiford indicated that DPW does not have enough preliminary information to meet with the homeowners however, when this information is made available, the committee will be contacted and the meeting will be set by Councilman Culbertson's office. I will continue to stay in contact with Council Culbertson regarding this matter and will advise you immediately if there are any changes. ## RECIPE OF THE MONTH



### Big Valentine Cookie

#### Ingredients:

- 1 package (18 ounces) NESTLÉ TOLL HOUSE Refrigerated Chocolate Chip, Chocolate Chunk, Chocolate Chip & White Fudge, Peanut Butter Chocolate Chip, Reduced Fat Chocolate Chip or Sugar Cookie Dough, well chilled
- Decorator icing (optional)
- Valentine's candies (optional)
- Melted chocolate (optional)

#### Directions:

SHAPE an entire package of cookie dough into heart shape on greased baking sheet.

BAKE according to package directions, adding 3 to 4 minutes to the baking time on the package. Cool on baking sheet for 1 minute; carefully loosen cookie with spatula. Cool on baking sheet completely.

DECORATE with candies, icing and melted chocolate.

## CELEBRATING BLACK HISTORY - FEBRUARY 2002

MARY ANN SHADD

Mary Ann Shadd was the first Black women editor of a newspaper in North America. She worked for racial integration in the United States. With the passage of the fugitive slave act in 1850, she decided that the future of Blacks looked better outside of the United States. Her conviction to the struggle for the rights of Blacks must have been inspired by her father Abraham Shadd, who was an abolitionist and opponent to the American Colonization Society.

Mary Ann Shadd was committed to the education of people of color. At the age of sixteen she went to Wilmington, Delaware to organize a school for children of color. Over the course of eleven years, Shadd taught in schools for black youth in New York, Pennsylvania and Delaware. In 1851, she joined the immigrationist movement and with her brother Isaac moved to Toronto, Canada.

Once in Canada, Shadd found herself locked in battle with Henry Bibb. Bibb was a staunch supporter of segregation in contrast to Shadd Ann who sought racial integration. Bibb published a newspaper called the Voice of the Fugitive in which he frequently attacked Shadd's desire to assimilate. With the motto "Self reliance is the fine road to independence." Shadd founded the paper Provincial Freeman where she in turn challenged Bibb's desire for separation. Shadd used the paper to discuss all aspects of Black life in Canada. The paper exposed all aspects of segregation and discrimination in Canada.

In 1855 Shadd was the first woman to speak at the National Negro Convention. Frederick Douglass said that she gave one of the most convincing and telling speeches in favor of Canadian immigration. Shadd would eventually abandon her belief in immigration but would maintain a strong desire for Black autonomy and maintain her belief in Black self help. During the Civil War she worked as an enlistment officer.

Shadd eventually obtained a Law degree and continued to write letters and articles for newspapers. She increasingly turned attention to gender equality and actively participated in supporting rights for women. Shadd testified before Congress on women's suffrage.

During her life she lectured extensively to many groups on subjects including race pride, the Ku Klux Klan, the Republican Party and women's rights. Frederick Douglass spoke highly of Mary Ann Shadd.

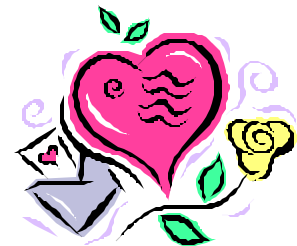

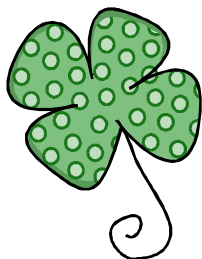

# The History of St. Patrick

Some 1,500 years ago, a teenage boy named Patricius, from what is now Great Britain, was kidnapped and enslaved by marauders from a neighboring country. Not since Paris and Helen of Troy has a kidnapping so changed the course of history. The boy they captured eventually became Saint Patrick. He escaped from Ireland, but returned of his own volition some years later. He had a vision and realized that he was handpicked by God to convert Ireland to Christianity.

So this former Britain turned Irishman forever changed Christianity as well as Ireland. The folklore and legends of St. Patrick come from myths about snakes and teaching people about Trinity by using a shamrock (hence the association of shamrocks with March 17). The chronology of his life is a bit confused and there is no way of telling when he was born, when he was ordained a bishop or when he died.

Only two documents exist that were written by the hand of Saint Patrick. In fact, they are the only written documents from Ireland or Britain from the fifth century. Experts do know, however, that he was born somewhere in Roman Britain into a somewhat wealthy family. He was not religious in his youth and there is evidence that he denounced his family's faith. He was enslaved to a local warlord and worked as a shepherd until he escaped some years later.

Upon his return, he started studying for the priesthood

with the intention of returning to Ireland as a missionary to his former captors. When he actually made it back is not clear or for how long he ministered there but it was definitely for a number of years. In the end, he made a commitment to Ireland and intended to die there and scholars agree that he probably did.

St. Patrick the man had humility and strength that helped him to overcome every obstacle he encountered while trying to convert the barbarians of Ireland. These were people who still practiced human sacrifice, who warred with each other constantly and were known as great slave traders of the day. It was definite that he had his work cut out for him and he worked his way through it himself without help.

During the six years he was enslaved, his education was set back and for this he would always be self-conscious. He was self-educated and should not have been considered uneducated by any means. He was an advocate against slavery for obvious reasons and became the first person to speak out against it. He was also an advocate of women as well and spoke of them in his writings as individuals, not temptations of flesh. He spoke of enslaved women and their high spirits despite the menacing terrors they endured. He was a great saint of the downtrodden and excluded.

By the time of his death, the Irish no longer participated in the slave trade and they never took it up again. Human sacrifice was also done away with, but war still remained a major theme though more confined and limited. The results of his conversions were astonishing and long lasting. He was responsible for the preservation of Western thought through the Dark Ages by the Irish monasteries founded by his successors. And when the lights went out all over Europe, Ireland remained one of the few lights left in the world.

## Green Punch Recipe

### Ingredients:

- 2 (3 ounce) packages lime flavored gelatin mix
- 1 quart hot water
- 1 (46 fluid ounce) can pineapple juice
- 2 (12 fluid ounce) cans frozen orange juice conc. (thawed)
- 2 cups white sugar
- 4 1/2 cups cold water
- 2 liters ginger ale

**Directions:** In a large saucepan dissolve the gelatin in 1 quart of hot water. Allow to cool. When gelatin is cool, pour into a large punch bowl, Stir in pineapple juice, orange juice concentrate, sugar and 4 1/2 cups cold water. Pour in ginger ale just before serving. **\*makes 20 servings**

## EASTER EGGS – DID YOU KNOW?

Of all the symbols associated with Easter, the egg is the most identifiable. It is the symbol of fertility and new life. For centuries, eggs have been associated with the customs and traditions of Easter.

Originally Easter eggs were painted with bright colors to represent the sunlight of spring. They were used in Easter-egg rolling contests or given as gifts. After they were colored and etched with various designs, the eggs were exchanged by lovers and romantic admirers, much the same as valentines. In medieval time, eggs were traditionally given to the servants at Easter. In Germany, eggs were given to children along with other Easter gifts.

Different cultures have developed their own ways of decorating Easter eggs. The people of Greece exchange Crimson eggs to honor the blood of Christ. In parts of Germany and Austria, green eggs are used on Maundy Thursday (Holy Thursday). Slavic people decorate their eggs in special patterns of gold and silver.

Austrian artists design patterns by fastening ferns and tiny plants around the eggs. Then the eggs are boiled and the plants are removed, revealing a striking white pattern. The Poles and Ukrainians decorate eggs with simple designs and colors. A number of eggs are made in the distinctive manner called *pysanki* (to design, to write).

*Pysanki* eggs are a masterpiece of skill and workmanship. Melted beeswax is applied to the fresh white egg. It is dipped in successive baths of dye. After each dip, wax is painted over the area where the preceding color is to remain. Eventually a complex pattern of lines and colors emerges into a work of art.

In Germany and other countries, eggs used for cooking were not broken, but the contents were removed by piercing the end of each egg with a needle and blowing the contents into a bowl. The hollow eggs were dyed and hung from shrubs and trees during Easter Week. The Armenians decorate hollow eggs with pictures of Christ, the Virgin Mary, and other religious designs.

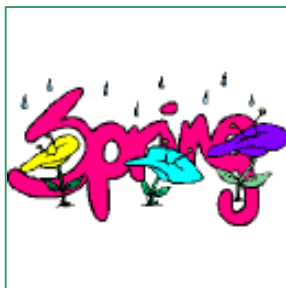

Operation KidSafe will take a child's picture using a Digital Video Capture Device that interacts with our custom software. The software then captures the child's fingerprints, using digital ink-less fingerprint capture device, and includes them as part of the child's file. The parent is provided with an 8½"X11" printout, containing the photograph & fingerprints. In the upper right-hand corner is an individualized security number. The parent can use the copy they receive to turn over to law enforcement anywhere in the world to instantly aid in an investigation.

## Annual Household Hazardous Materials Collection Day & Paint Swap Saturday, April 13<sup>th</sup> 8:00am-12:00pm

The East Baton Rouge City Parish, Dow Chemical Company, and the Louisiana Department of Environmental Quality will hold the annual household hazardous waste collection Saturday, April 13th.

The Baton Rouge collection begins at 8 a.m. and runs until noon in the Memorial Stadium parking lot. Please enter from Scenic Highway at Foss Street. The Department of Public Works will have directional signs posted and there will be police officers stationed at critical points to direct participants to the site. There may be some delay but, please be patient and follow directions so that everyone can benefit from this event. For more directions see the map to the right.

Dow will be collecting items such as fertilizers, pesticides, pool chemicals, household cleaners, and other common household products that contain hazardous materials and should not be disposed with general household waste in the landfill. This is a non-commercial collection day, residential collection day only.

This will be the 20th Household Hazardous Waste Material Collection since 1985 when the program began. Last year's collection prevented 186,287 pounds of household hazardous waste from being disposed in the landfill. Over time, the annual collection has diverted a total of 1,325,207 pounds.

The first 1,000 participants can also trade in their old leaky gas cans and receive a new 2.5-gallon environmentally friendly gas can from Dow for free.

In conjunction with the collection, DEQ will sponsor a paint swap at the event in Baton Rouge. Used motor oil collection will be sponsored by ExxonMobil. The Corporate Recycling Council will be collecting used electronic equipment including computer hardware, cell phones, copiers, fax machines and more, and Exide will be collecting used automotive batteries. Lamp Recyclers of Louisiana will accept fluorescent bulbs and elemental mercury articles and Southern Scrap Express will collect scrap metals.

## Happy Father's Day

Father's Day, contrary to popular misconception, was not established as a holiday in order to help greeting card manufacturers sell more cards. In fact when a "father's day" was first proposed there were no Father's Day cards!



Mrs. John B. Dodd, of Washington, first proposed the idea of a "father's day" in 1909. Mrs. Dodd wanted a special day to honor her father, William Smart. William Smart, a Civil War veteran, was widowed when his wife (Mrs. Dodd's mother) died in childbirth with their sixth child. Mr. Smart then raised the newborn and his other five children by himself on a rural farm in eastern Washington state. It was after Mrs. Dodd became an adult that she realized the strength and selflessness her father had shown in raising his children as a single parent.

The first Father's Day was observed on June 19, 1910 in Spokane Washington. At about the same time in various towns and cities across American other people were beginning to celebrate a "father's day." In 1924 President Calvin Coolidge supported the idea of a national Father's Day. Finally in 1966 President Lyndon Johnson signed a presidential proclamation declaring the 3rd Sunday of June as Father's Day.

## About the project:

- In August of 2001, the city contracted with Professional Engineering Consultants Corporation (7600 GSRI Avenue Baton Rouge, La 70820 225-769-2810) to design the extension from Burbank to Nicholson Drive
- The total estimated cost of the project is 8 million dollars. The majority of the cost of the project is the addition of drainage/curb and gutter, 1/8 of the cost is the asphalt overlay.
- In October or November of 2002, the project will be advertised for bidding for a minimum of 25 days.
- The Metro Council will review the bid(s) and make a selection.
- All parties will execute the contract with construction beginning shortly thereafter.
- The construction is tentatively scheduled to begin in the Fall of 2002, but may not begin until January 2003.
- The project is expected to take approximately 1 year to complete.

## About the Road:

- The extension will consist of two parts – Residential and Rural with a 4 Lane Boulevard – 2 lanes in each direction for 2 ½ miles. The road will be equipped with an asphalt overlay, used as a sound barrier for quieter riding. It will also include curb and gutters throughout. The drainage will be enhanced with enlarged piping to carry the water load.
- New drainage pipes will be installed first.
- All necessary elevations will be met – will be raised in grade 1-foot in some areas where necessary.
- Existing road will be completely taken out. A temporary roadway will be erected on one side, while the other side is being constructed.
- Two lanes will be open at all times to allow entrance and exit from the neighborhood.
- Contractor will maintain driveways during construction allowing those residents living on Bluebonnet access to their homes.
- The existing 100ft right-of-way will be undisturbed.
- The existing 30ft grass median will be reduced to 20ft, with the roadway extending 7ft closer to homeowners along the Boulevard.
- There will be a 10ft landscape servitude. Existing landscaping has not been fully addressed. Landscape plans will be addressed and presented to the Bluebonnet Highlands Committee Members.
- The existing 5-foot sidewalks will remain undisturbed.
- Sidewalks are proposed from Burbank to Nicholson.
- The boulevard will have lighting from Nicholson to Burbank.
- Trucks carrying hazardous materials will not allowed from Nicholson to Burbank.
- Traffic light to be considered near the Recreational Center because of concern for the safety of children traveling on foot.
- The first set of mailboxes for Springlake will be relocated. This will be discussed with Clark Taylor.





## Abandoned Baby Ducklings

# Hurricane Season

Did you know that Hurricane Season lasts from June through September?  
It's time to start thinking and preparing for the possibility. It pays to be prepared.

---

## Do you have an Evacuation Plan?

- Where would you go if you are told to evacuate?  
Choose a few different places – an out of town relative, an out of town friend, a hotel.
- Have telephone numbers and road maps handy
- Listen to radio or TV for evacuation instructions. If you are advised to evacuate, then do it right away. The longer you wait, the more traffic and congestion there will be.
- Do your family members know where to meet you?
- Do your out of town relatives know where to reach you?

## Prepare a Hurricane Disaster Kit

Some items you may want to include:

- First aid kit
- Essential medications.
- Can opener and canned food
- Bottled water - at least three gallons per person.
- Protective clothing, rainwear, and bedding or sleeping bags
- Batteries and battery-powered radio and flashlight
- Keep in mind the needs of elderly or disabled family members.

## Hurricanes Bring High Winds

- You can buy pre-cut 1/2 inch outdoor plywood to cover each window of your home. It would be a good idea to pre-drill any holes so that it can be installed quickly in case there is a need.
- Trees can be made less wind resistant. Trim dead or damaged limbs and selectively remove branches to thin and therefore allow the wind to blow through.
- Bring in or secure lawn furniture, trash cans, potted plants and other items that could be blown and cause damage.

## What should you do in case of a Hurricane WATCH?

A hurricane watch means that hurricane conditions are *possible* within 36 hours.

- Listen to the radio and TV for up-to-date information. Forewarned is forearmed.
- Make sure you have a full tank of gas in case you need to evacuate
- Think about covering windows
- Make sure you have an evacuation plan
- Have your Hurricane Disaster Kit ready

## What should you do in case of a Hurricane WARNING?

A hurricane warning means that hurricane conditions are *expected* within 24 hours.

- Listen to the radio and TV for up-to-date information.
- If you are told to evacuate, then do it quickly
- Stay inside and away from windows.
- Remember that the eye of the storm is deceiving and just because the storm calms down, does not mean that it is over. The worse part of the storm is on the other side when the wind blows the opposite way.
- Tornadoes can be a by-product of hurricanes. In case of a tornado, stay inside and move to a central part of the home away from windows. Go to a closet or bathroom.
- Beware of flood waters. Do not drive through a flooded street. Six inches of moving water can knock a person down and as little as two feet of moving water can wash away your car. If you get stuck on a flooded road with rising water, get out of your car and climb to higher ground.
- If the power goes out, please use flashlights rather than candles.

## Clubhouse Etiquette

The pool area and grounds are to be enjoyed by all residents who have paid their dues and wish to relax and enjoy! As you know, a clubhouse committee has been formed to oversee the clubhouse to ensure it is ready for your everyday use. Many of our members work and volunteer their extra time to check the clubhouse on their duty days. Remember to be responsible for your actions. Please help the members by adhering to the following clubhouse etiquette rules:

1. No eating in the pool (large or small kids wading pool). Please utilize the pool tables/umbrellas to enjoy your snacks and sodas. Additionally, there is a picnic table near the playground equipment for your use if the poolside tables are taken.
2. No horseplay in the pool area or in the pool(s).
3. Adults should accompany small children in the restrooms.
4. Please remove all trash from the patio tables. Be courteous - wipe up drink spills and wipe down your chaise lounge after sunning to remove residual tan oils, lotions, etc.
5. Please lower the umbrellas after use.
6. Turn outside showers to "off" after use.
7. Turn off lights in restrooms after use. This will keep our costs down and conserve energy.
8. If you use the skimmer, please return it to the area kept alongside the fence closest to the clubhouse.
9. DO NOT allow entrance for other homeowners with the use of your gate key pass. This is unfair to members who have paid their Homeowner Dues. If you have any questions regarding this policy, contact the Homeowner's Association at 293-8320.
10. Follow all rules as posted regarding the Tennis Court.
11. Please throw empty tennis ball canisters into the trash can.

As a reminder, the pool is closed on Mondays for cleaning and maintenance. Mr. Guy Oliver is responsible for pool maintenance. Overall, he has done a great job, but if you notice the pool has an unusual amount of dirt or debris after the scheduled maintenance, please contact him at 954-2475. ## Happy Independence Day – Flag Etiquette

The Flag Code, which formalizes and unifies the traditional ways in which we give respect to the flag, also contains specific instructions on how the flag is not to be used. They are:

The flag should never be dipped to any person or thing. It is flown upside down only as a distress signal.

The flag should not be used as a drapery, or for covering a speaker's desk, draping a platform, or for any decoration in general. Bunting of blue, white and red stripes is available for these purposes. The blue stripe of the bunting should be on the top.

The flag should never be used for any advertising purpose. It should not be embroidered, printed or otherwise impressed on such articles as cushions, handkerchiefs, napkins, boxes, or anything intended to be discarded after temporary use. Advertising signs should not be attached to the staff or halyard

The flag should not be used as part of a costume or athletic uniform, except that a flag patch may be used on the uniform of military personnel, fireman, policeman and members of patriotic organizations.

The flag should never have placed on it, or attached to it, any mark, insignia, letter, word, number, figure, or drawing of any kind.

The flag should never be used as a receptacle for receiving, holding, carrying, or delivering anything.

When the flag is lowered, no part of it should touch the ground or any other object; it should be received by waiting hands and arms. To store the flag it should be folded neatly and ceremoniously.

The flag should be cleaned and mended when necessary.

When a flag is so worn it is no longer fit to serve as a symbol of our country; it should be destroyed by burning in a dignified manner.

## Constitution of the United States

The system of fundamental laws of the United States of America. The Constitution was drawn up by 55 delegates to the Constitutional Convention in Philadelphia during the summer of 1787 and ratified by the states in 1788. The Constitution defines distinct powers for the Congress of the United States, the president, and the federal courts. This division of authority is known as a system of checks and balances, and it ensures that none of the branches of government can dominate the others. The Constitution also establishes and limits the authority of the federal government over the states and spells out freedoms and liberties for U.S. citizens.

# Fourth of July Bake

(Casserole)



1. Pour 14 ounces of elbow macaroni in 4 quarts of rapidly boiling water. Boil 4 to 6 minutes. Drain.
2. Empty into large baking dish. Sprinkle with grated cheese.
3. Arrange 16 cherry tomatoes as the stars in flags and 8 frankfurters as the stripes.
4. Place in 375 degrees oven and bake for 15 to 20 minutes. Serves 4.

## Patriotic Mold

### Red Layer:

1 (3oz.) pkg Jell-O strawberry gelatin (use 1 1/3 cup water)  
1 (10oz) pkg Bird's Eye quick thaw strawberries

### White Layer:

1 (3oz.) pkg Jell-O lemon gelatin (use only 1 cup water)  
1 pt. Vanilla ice cream, slightly softened

### Blue Layer:

1 (3oz.) pkg. Jell-O Lemon, black cherry, or Concord grape or black raspberry gelatin  
1 1/2 cup fresh, froze or drained canned blueberries, mashed  
1/2 cup sugar  
1 cup boiling water  
1/2 cup cold water

Dissolve strawberry gelatin in 1 1/3 cups boiling water. Add frozen strawberries. Stir gently until fruit thaws and separates. Chill until thickened. Pour into an 8 cup mold (star-shaped, if desired), a 9-cup Bundt pan, or straight-sided saucepan. Chill until set, but not firm.

Dissolve 1 package lemon gelatin in 1 cup boiling water. Blend in ice cream, beating until smooth. Chill until thickened. Spoon over strawberry mixture in mold. Chill until set, but not firm.

Dissolve remaining package of lemon gelatin and the sugar in 1 cup boiling water. Add 1/2 cup cold water; chill until thickened. Stir in blueberries and spoon over lemon ice cream mixture in mold. Chill until firm, or overnight. Unmold. Makes about 8 cups or 12 to 14 servings.

## Fireworks Safety



To help you celebrate safely this Fourth of July, the Consumer Product Safety Commission and the National Council on Fireworks Safety offer the following tips:

- Always read and follow label directions.
- Have an Adult present.
- Buy from reliable sellers.
- Use outdoors only.
- Always have water handy ( a garden hose and bucket ).
- Never experiment or make your own fireworks.
- Light only one firework at a time.
- Never relight a "dud" firework (wait 15 to 20 minutes and then soak it in a bucket of water).
- Never give fireworks to small children. If necessary, store fireworks in a cool dry place.
- Dispose of fireworks properly by soaking them in water and then disposing of them in your trashcan.
- Never throw or point fireworks at other people.
- The shooter should always wear eye protection and never have any part of the body over the firework.
- Stay away from illegal explosives.

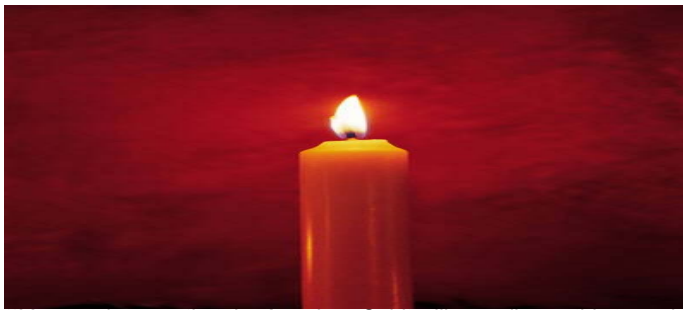
## One Year Later...

## Homeowner Meeting Recap

The following is a summation of the Annual Homeowner's Meeting held Thursday, August 29, 2002 at the Bluebonnet Branch Library. Due to work related travel and illness, the Newsletter Staff was not able to attend the meeting, however, we were able to contact one of our residents, Mr. Paul Roberts, who provided us with the information below. If you have any comments, questions or concerns regarding our neighborhood, the association or items in general, please feel free to email the newsletter @ [www.bluebonnethighlands.org](mailto:www.bluebonnethighlands.org). We will forward your questions to Clark Taylor and Associates.

- Clark Taylor began the meeting by reviewing the income and expenses from 1/1/02 thru 8/29/02. The debt owed on the Clubhouse has been refinanced to a lower interest rate therefore saving the BHHA, Inc on interest expense. In addition, the balance sheet reflects an account receivables with a past due balance (past due homeowner dues) of **\$18,541.00**. It was suggested that this list of residents be posted on the newsletter website however, legal ramifications are unclear. 58 Springlake Residents & 27 Fairhill Residents are on the list. **Call Debbie directly at 293-8320** if you want a copy of the list.
- There was some discussion regarding hunting on the adjoining property to Fairhill. Homeowner's suggested calling the Sheriff's department – Sheriff's department stated assistance would be provided only if shots were within 200 yards of the property. Clark Taylor will look into contacting the property owner regarding putting up posted signs.
- The mailboxes for Springlake is a dead issue. Only 25 residents signed the petition online. The post office will not issue individual boxes for residents and Clark Taylor has no influence with the Postal Service.

## Homeowner Meeting Recap *(cont'd)*

- Bluebonnet Extension – Clark Taylor deferred to Paul Roberts who is a committee member. Paul advised residents to check out the website and read the latest events regarding the extension. See “The Bluebonnet Highlands Extension” section.
- Big discussion regarding signage along Bluebonnet. Residents want the signs removed or redesigned to look more updated. Clark Taylor agreed to look at redesign. Clark deferred this issue to Paul Roberts, a builder in Springlake. Paul agrees the signs need to be updated, however, he stated he thinks the signs should remain because in his opinion, the signs attract buyers to a particular price range. If the price is right, they enter. If not, they don't. The signs are very common, for example, in Houston, TX. **Jane St. Amant, Debbie Murphy, Paul Stephens and Kim Scullin** volunteered to serve on the redesign committee. As soon as we know more about the committee and their agenda, we will post online.
- Builders – Lots of trash, burning trash and debris. What to do? Various homeowners complained about trash from construction sites accumulating on their lots/homes. Complaints about burning trash ignored. Mr. Taylor commented that it is legal to burn outside of the city limits and suggested calling the Fire Department.
- Speeding drivers and stop sign runners. (residents and other individuals) – Call the Sheriff's Department.
- Restrictions / Violations – There is a home in Fairhill that is being built by an individual and is suspected by other homeowners of not meeting restrictions for square footage and landscaping. Debbie DeJean is aware of this situation and is working on resolving. If you notice violations of the act of restrictions, it is suggested that you take digital photos and email them to Debbie DeJean @ [dejean4121@cox.net](mailto:dejean4121@cox.net).
- Only **54** residents attended the homeowner's meeting. We have approximately **470** residents. Homeowner's – **PLEASE** get involved. Our meeting is only scheduled once a year however; if you have some concerns, please make sure you are heard. Our clubhouse can be used as a meeting place to address homeowner concerns.

- **Springlake is growing** – Builder source says Springlake V had been presold for 54 out of 55 lots even before the streets were laid! Fairhill is on fire with activity! This is excellent growth for our neighborhood! Jane St. Amant, resident of Springlake and Realtor, told us Springlake V should have power to the streets by month end. She noted interest rates are at an all time low so those of you interested in purchasing or refinancing, consult your local lenders.
- **August 2<sup>nd</sup>, around 2pm, a Hilltree Drive resident drives up to home and finds unknown black male on premises.** She sounds horn to alert him, calls husband and Sheriff's dept. Sheriff questions man who says he was looking for a jobsite. The Sheriff's charged him with trespassing and allowed him to leave since nothing was taken from the property. The residents were unharmed.
- **Mid August, Springrose Resident notified us about late night congregation on the streets in the new filing of Springlake.** It appeared that several young people were meeting on the new street after hours. After the commotion was heard, the Sheriff's Department was called and the individuals were asked to leave.
- **August thru September** – Young boys trespassing. Gaining access to clubhouse grounds by jumping the fence and/or waiting for residents to open the gate to ride in on bikes. They have been asked to leave several times. They are extremely belligerent – Do not try to address them. Call the Sheriff's department. They are not residents of Bluebonnet Highlands.



## A Letter to the Editor

Recently, I received an email from Marietta Del Favero, a Springlake Resident. With her permission to reprint, I would like to share her comments with the neighborhood. Bluebonnet Highlands is a great community and I'm sure we'd all like to keep it that way – *Kim Walker*

*"Reviewing past association minutes, there appear to be several issues that are not new that I feel will ultimately, if they have not already, bring out property value down...."*

- 1. I generally have no problem with parking on the street, but I have noticed often that people are parking in front yards or on the grass easement next to the street. This is a common sight in sub par neighborhoods, e.g. inner city slums, and one I think should be subject to penalties, if even it is just noting the offenders in the newsletter.*
- 2. The same goes for people who do not keep up their lawns. 12-inch high grass is not characteristic of a neighborhood that has pride of ownership. Individuals who walk their dogs and leave unsightly gifts on the lawns of others need to be addressed with more than just friendly reminders in the newsletter. In many communities, people walking dogs without a pooper-scooper in their hand can be reported and fined. Here may be a good source of revenue for the upkeep of the Yard of the Month sign!*

*I urge the Board to get a handle on these issues as the property values of all are being negatively affected".*
